SITE SAFETY INSPECTIONS

To ensure the project is being managed safely and in compliance with CDM 2015 as well as other legislative requirements, Safetyform offer an on-site safety inspection scheme, as part of the advisory package or a stand-alone service offering.



COMPETENCE ASSESSMENTS

Safetyform will work with you on your construction project from beginning to end to ensure the project is delivered on time, on budget, safely and in compliance with the requirements of the Construction (Design & Management) Regulations 2015 (CDM).



CDM ADVISOR

Safetyform provides a fully comprehensive CDM advisory service with a designated 'CDM Advisor' allocated as your single point of contact throughout the whole project. Working closely with you to ensure that you fulfil your duties as required by the Regulations.



PRINCIPAL DESIGNER

Design decisions made during the pre-construction phase significantly influence the health and safety of everyone affected by the work. CDM 2015 requires the Client to appoint a Principal Designer and Principal Contractor where there is or is likely to be, more than one contractor working on a project.

The Principal Designer (which may be an organisation or individual for smaller projects) therefore takes control of the pre-construction phase of any project involving more than one contractor. As the Principal Designer appointed to your project, we will plan, manage and monitor the pre-construction phase and identify and eradicate or reduce, significant risks during design.

- Make you aware of your duties as a client
- Identify pre-construction information
- Gather the pre-construction information and distribute it to those that need it
- Work with designers to ensure they carry out their duties
- Identify foreseeable risks and look to reduce or eradicate them through design
- Notify the Enforcing Authority of the project on your behalf
- Ensure a construction phase plan has been drawn up
- Develop the Health and Safety file



FIRE SAFETY



FIRE SAFETY LEGISLATION

The Regulatory Reform (Fire Safety) Order 2005 (RRO) came into effect in October 2006 and is the main legislation covering fire safety in the UK. In addition the Fire Safety Act 2021 (FSA) has now been put through parliament and will become a key piece of legislation for which organisations will need to comply. The RRO, supported by the FSA, place specific duties on those who are responsible for managing fire safety with their organisation, in particular The Responsible Person.



FIRE RISK ASSESSMENTS

The Responsible Person, as deemed under the RRO, must undertake a suitable and sufficient assessment of the risks to which relevant persons are exposed for the purpose of identifying the general fire precautions they need to take to comply with the requirements and prohibitions imposed on them.

CARRYING OUT THE ASSESSMENT:

- Identify the fire hazards
- Identify people at risk
- Evaluate, remove or reduce the risks
- Record your findings, prepare an emergency plan and provide training
- Review and update the fire risk assessment regularly

FIRE DOOR INSPECTIONS

The RRO requires that, where necessary, the responsible person ensures that all facilities, equipment and devices provided for fire safety are maintained and that a maintenance system is in place. Fire doors form part of those facilities and should be regularly inspected to ensure suitability & integrity. It is recommended that fire doors are inspected every 6 months. Safetyform have a team of trained fire door inspectors who can perform your fire door inspections.



EMERGENCY PROCEDURES

One factor in ensuring you can escape from a building safely and quickly is dependent on having suitable emergency procedures in place. Allow Safetyform to conduct a review of your emergency procedures and give you that peace of mind they are fit for purpose.
